I agree to follow the regulations and research scholarship contract of Christian University of Thailand represented by the President of Christian University of Thailand as the grantor and the Research Promotion Committee is assigned to proceed according to this contract which is hereinafter called “The Grantor” in the following statement.

Item 1, The grantor has approved research scholarship in academic year..... for baht (.....) to the recipient. The research is scheduled to finish within 1 year since contract signing which falls on date month year and will end on date month year


If the researcher cannot submit the research papers on the designated time with an appropriate reason, he/she is eligible to request an approval from the grantor to extend the time to not over 6 months after the due date.

Item 2, For the disbursement of research scholarship, the grantor will grant the research scholarship in periodical payments as follows;

First payment, 40 percent, Baht (.....) after the research proposal is approved and the scholarship recipient signs this Research Scholarship Contract.

Second payment, 40 percent, Baht (.....) when the scholarship recipient submits research progress report and preliminary research findings (Chapter 1 to Chapter 4) to the Research Promotion Committee and received an approval to drawdown the 2nd payment.

Third payment, 20 percent, Baht (.....) when the scholarship recipient submits two copies of full research paper which had been checked by Learning Resource Center and Library that the contents of the soft file and the full paper are identical, and evidence of research publication in national academic journals of TCI database system or journals accredited by OPDC or international journals or research presentation at national and international academic conference.

Item 3, the scholarship recipient knows and understands the regulations and conditions of Research Scholarship Contract and will obligate strictly with the regulations of research scholarship.

Item 4, the scholarship recipient will conduct research with perseverance to accomplish the purpose of the grantor. If there is any obstacle, the scholarship recipient will immediately report to the grantor through the Research Promotion Committee of Christian University of Thailand.

Item 5, the scholarship recipient ensures that every 3 months from the date of signing this contract, the research progress report will be submitted even it has not yet completed. When the research is completed according to the time specified in the project, the scholarship recipient will submit full research paper according to the conditions of the grantor.

Item 6, The intellectual property of the research result supported by the scholarship of this contract belongs to the grantor only unless otherwise agreed by both parties before signing the contract. If the research results are used for commercial benefit, the benefit will be shared to the research fund according to the agreement.

Item 7, the grantor is entitled to take all or some part of the research results to disseminate in document or publication or other media or research with a purpose of academic development.


In case the scholarship recipient will bring all or some part of the research to publish in documents or other publication or to demonstrate to public in any places, the scholarship recipient will take full responsibilities and ensures to state the acknowledgement as follows: *“This research project was financially supported by Christian University of Thailand, Academic Year”*

In case the research results of this project will lead to an invention or product design, the scholarship recipient will not publish neither all nor some part in any documents or medias until the grantor has registered a patent for such invention or such product design completely.

Item 8, the scholarship recipient certifies that all documents or statements in the documents that the scholarship recipient submits to request for the scholarship or informs the grantor including the research report of this project and financial evidence submitted to the grantor are true in all aspects and agrees to be verified.

In case any statement in the contract appendix conflicts with the statement in this contract, the statement in this contract will prevail. And in the event of discrepancies in the appendix, both parties have to make an agreement to comply with the purpose of this contract.

Item 9, if the scholarship recipient breaks the contract and does not submit the research paper in item 1, the scholarship recipient agrees to return full research scholarship to Christian University of Thailand plus the interest 7.5% according to Civil and Commercial Law. If the researcher has not yet disbursed the scholarship, the scholarship recipient has to pay the fine 7.5% of total scholarship. The scholarship recipient agrees to be deducted from the salary or other income of the researcher depending on case by case.
